



## SOLUTION SHEET FOR EARTH CARE ODOR ELIMINATOR PRODUCTS

**MANY PCO'S NOW OFFER ODOR CONTROL SERVICES TO THEIR EXISTING CUSTOMERS  
PROVIDING AN ADDITIONAL SOURCE OF INCOME, HERE ARE SOME EXAMPLES:**

### **TRASH ROOMS:**

Trash room odors can be an exceptionally difficult problem when they are located next to restaurants and grocery stores and the odor drifts inside the establishment. Hang two bags for every dumpster, change out monthly. Once per month sprinkle 28 oz (800 grams) of granules over trash in dumpster.

### **CIGARETTE SMOKE AND BAR/RESTAURANT ODORS:**

Hang 1 bag per 50 square feet (4.5 square meters), change out monthly. Refrigerators and walk-ins: Hang 1 bag in refrigerator or walk-in, change monthly.

### **REST ROOMS AND PORT-A-POTTY:**

Hang 1 bag in each restroom or Port-A-Potty, change out monthly.

### **MUSTY MILDEW ODORS:**

If an area was previously flooded or subjected to severe dampness apply granules to the floor. Use 1 pound (455 grams) of granules per 100 square feet (9 square meters). Leave down 48 hours and vacuum or sweep up. If applied to dirt or landscaping granules can be left down indefinitely. Also hang 1 bag per every 100 square feet (9 square meters). Change bags every 1 to 2 months.

### **SKUNK AND WILD LIFE ODORS:**

If skunk has sprayed on furniture, flooring, or truck/car apply granules to floor and furniture, use 1 pound (455 grams) per 50 square feet (4.5 square meters). Leave down 48 hours and sweep or vacuum up. Often skunk odors will require a 2nd or 3rd application to completely eliminate the odor. If skunk has sprayed on dirt or landscaping, apply granules, not necessary to remove granules. Reapply as necessary. If skunk has sprayed a pet or human, sprinkle directly on skin or fur, fluff into fur, leave on as long as pet tolerates it. Let pet shake off granules, reapply as necessary. Will not hurt pet or human even if eaten.

### **RODENT INFESTATIONS AND CARCASS IN WALL:**

Simply hang a bag in every room you smell the odor. Use a minimum of 3 bags total, 1 per 100 square feet (9 square meters). If the carcass is suspected to be in a crawl space, under a structure, or in an attic, add additional bags in those areas. It is not necessary to remove the carcass if it cannot be found. If body fluids have soaked into wood, drywall, etc, granules can be applied to the affected area to expedite ridding the odor.

### **BED BUG AND ROACH INFESTATION ODORS:**

Hang 2 bags in each room that has been treated for bed bugs or roaches.

### **FERAL CAT INFESTATION AND PET ODORS:**

Apply granules directly to floor, use 1 pound (455 grams) per 100 square feet (9 square meters). Room should have some air circulation. Leave down 48 hours and vacuum or sweep up. If applied to dirt or landscaping not necessary to remove. Also hang 1 bag per every 100 square feet (9 square meters). Occasionally areas with heavy cat urine will require 2nd application. For cat boxes, add 1/2 cup (4 oz, 100 grams) on bottom of sand box and 1/2 cup (4 oz, 100 grams) each time sand is scooped.

### **NEW CARPET AND FURNITURE OFF GASSING:**

Hang bags in each room where you smell the new carpet/furniture odor. Use a minimum of one bag per 100 square feet (9 square meters). Also sprinkle granules on carpets and leave down 24 hours, vacuum up. Use 1 pound (455 grams) per 100 square feet (9 square meters).

### **AUTO, RV, BOAT ODORS:**

Hang bags in each room on the boat or RV to rid musty mildew odors and bathroom odors. If odors are very strong, apply granules to carpet and furniture. Leave down 24 hours and vacuum or sweep up.
